Inspector Observations: Two fresh-appearing rodent droppings on floor between the kitchen and dry storage room. About 5 very dry objects appearing to be old rodent droppings in the dry storage room on the floor. Observed backdoor was propped wide open, which leads near the refuse area. [CA] Each food facility shall be kept free of evidence of vermin activity: rodents (rats, mice), cockroaches, flies. Keep back door closed. [COS] PIC had the droppings removed and sanitized the floor with over 200 PPM free chlorine solution. Back door was also closed.

Overall Comments:

Follow-up inspection to routine inspection conducted 10/13/2021.

No evidence of cockroaches observed. Per PIC pest control service was completed yesterday and chemical was applied to floor areas, however, there is no receipt. Per PIC floors and equipment were cleaned. Most coved base areas have been re-sealed.

Within the next couple days: reseal any remaining crevices, install face plates on uncovered electrical outlets, and replace wire covers on wall openings with solid easily cleanable, smooth, durable, and nonabsorbent material such as FRP. Clean any remaining food debris on equipment.

The 1 door fridge is only storing soda and the large 2 door prep fridge has no food (measured 42F ambient). Per PIC the prep fridge will be serviced today and will also try to have the 1 door fridge serviced as well through beverage company contract.

Observed rodent droppings - see K23 above.

- A follow-up inspection will occur on or before Tuesday October 19, 2021 and will be a billable follow-up, \$219 per hour, minimum 1-hour.

- Due to repeat violations, an office hearing with Environmental Health Department and the owner will be scheduled.

- PIC requests 2-month permit, valid until November 30, 2021. PIC states that employee amount has been reduced to 5 employees. Permit category will be reviewed for adjustment to FP11 FOOD PREP / FOOD SVC OP 0-5 EMPLOYEES RC 3 \$ 1,227.00/Year.
