Overall Comments:

This is the second follow up inspection for the routine inspection where the facility was closed for an active cockroach infestation and will be charged.

Observations:

- The affected areas have been cleaned and sanitized. A singular dead cockroach was observed on the wall under the cold hold cooler. No other evidence of a cockroach infestation observed.
- Facility is okay to reopen. Discussed creating a master cleaning schedule to facilitate frequent and proper maintenance of the facility due to its size.
- The first follow up inspection is free of charge. Any and all subsequent follow up inspections shall be charged at the approved hourly rate of \$298.00/hr, minimum of one hour, during normal business hours: Monday through Friday 7:30am to 4:30pm or \$645/hour minimum two hour during non business hours, and upon inspector availability.

FACILITY RE-OPENED / PERMIT REINSTATED

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
