Follow-up inspection for major violation #7 (food temperatures) and minor violations #23 (rodent droppings). Observed rodent droppings on floor under utensil storage (back part of kitchen adjacent to dry storage room) and observed live cockroaches in all different life stages in the kitchen. Facility must close, eliminate pests and droppings, and call for a reinspection to reopen. Facility is subject to a charged inspection of \$219.00/hr.
