## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

**Inspector Observations: cooked beef in preparation refrigerator measured 57F and held for less than 30 min. [CA] PHFs shall be held at 41°F or below or at 135°F or above. [SA] PIC stated that the cooked beef was held in the preparation refrigerator for less than 30 minutes. The beef was moved to the walk-in refrigerator for rapid cooling.**

K09 - 3 Points - Improper cooling methods; 114002, 114002.1

**Inspector Observations: Rice found cooling at the preparation table covered with plastic. [CA] When cooling PHF's, food may be left uncovered or loosely covered to allow rapid cooling.**

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

**Inspector Observations: Leak observed at drain line under cooking equipment. [CA] Repair plumbing fixture and maintain in clean and good repair.**

**Condensation line found leaking inside the walk-in refrigerator. [CA] Repair the plugged condensation line.**
