Major Violations

Inspector Observations: Observed raw meat stored above cooked/ready to eat foods in the walk in. [CA] always store raw meat, seafood, and poultry below all other foods. [COS] The meat was placed below the other foods.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: Observed the boxes of utensils open and able to become contaminated. [CA] Keep the plastic bags closed to protect clean utensils from contamination. [COS] The bags were all closed.
