Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: The hand sink is soiled. The handles have a thick layer of encrusted grime on them. [CA] Thoroughly clean the hand sink and remove the grime from the handles.
The inside of the walk in refrigerator and freezer has accumulated buildup on the floors and some areas of the walls.. [CA] Thoroughly clean the inside of these units.

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

Inspector Observations: The lighting in the walk in cooler is very dim. So dim that we are unable to see which food items are inside and also unable to see the walls thoroughly. [CA] Increase the lighting in the walk in so that you can see all items inside the unit.
The hood vents have accumulated thick layer of grease and beginning to drip down onto the cooking surfaces. [CA] Clean the hood and vents and remove the grease.

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

Inspector Observations: Observed used wiping towels on the table tops. [CA] Store the wiping towels in a sanitizer bucket in between each use.

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Inspector Observations: The screen door on the back door does not close properly and the back door is left open. [CA] Replace the screen door so that it remains closed to help to keep the insects out.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: The floor is soiled under the food storage shelves. Grime has accumulated on the floor around the legs of the equipment. [CA] Thoroughly clean the floors and remove the grime off of the floor.
