## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: The hand soap dispenser was not working due to the battery being dead. [CA] Be sure the soap and paper towel dispensers are working properly. [COS] Replaced the battery and it is now working.**

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

**Inspector Observations: The wall mounted sanitizer dispenser is giving the quat sanitizer at 100ppm. [CA] The dispenser must dispense at proper concentration at 200ppm. the employee adjusted it by hand in the sink. Continue to have the dispenser worked on to give proper concentration.**
