Inspector Observations: Observed a dead cockroach on the floor near in the dry storage room. [CA] Clean up the cockroach and take effective measures to eliminate the insects from inside the facility.

Inspector Observations: The cutting board under the beverage machine is very soiled and needs to be removed. [CA] Remove this as it is soiled underneath also and it is bolted down. Completely wash and sanitize or replace with new.
