Overall Comments:

Environmental Health permit was suspended on 08/28/2026 due to cockroach infestation. A follow-up inspection was conducted today.

Owner obtained pest control service from Polaris Pest Elimination on 09/02/2026. Follow-up services were made by the pest control company on 09/03, 09/04, and 09/06. On the latest report from 09/06/2026, the technician noted "no live cockroaches or infestation were observed".

At time of this inspection, no live cockroaches were observed. One dead one was found near the walk-in cooler. Owner removed the cockroach. Cleaning was partially done. Food debris and residue was still found at the back corner of this facility, behind the table with the microwave. Continue to clean areas that have not been cleaned. Observed some cracks sealed with caulking.

Per owner, pest control service will be continued on a monthly basis.

Paper towel dispenser in the kitchen has been repaired.

Environmental Health permit to be reinstated. This facility is okay to operate.

Continue to correct the following:

- Obtain a valid Food Safety Certificate*
- Have exhaust hood cleaned to remove grease*

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **9/21/2026**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
