## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

**Inspector Observations: Not all employees preparing food have valid food handler cards.**  
**[CA] Each food handler shall maintain a valid food handler card for the duration of his or her employment as food handler. A valid food handler card shall be provided within 30 days of after the date of hire.**

K29 - 2 Points - Toxic substances improperly identified, stored, used; 114254, 114254.1, 114254.2

**Inspector Observations: Observed a spray bottle with purple cleaning liquid in it unlabeled. [CA] Label each spray bottle with its contents.**

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

**Inspector Observations: The dish washing machine reached 135 degrees F in the rinse cycle.**  
**[CA] Water in the rinse cycle must be at or above 171°F for 30 seconds in the high temperature dishwasher.**  
**Discontinue using the machine until it can work properly. Wash, rinse, and sanitize in the 3 compartment sink.**

K38 - 2 Points - Inadequate ventilation and lighting in designated area; 114149, 114149.1, 114149.2, 114149.3, 114252, 114252.1

**Inspector Observations: Observed some lights out in the back kitchen area. [CA] Replace the missing lights.**

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

**Inspector Observations: Observed used wiping towels on table tops. [CA] Keep the used wiping towels in sanitizer between each use.**

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

**Inspector Observations: Observed several drain pipes in the floor sinks. [CA] Remove the drain pipes from inside to provide the required air gap between the pipe and top of the floor sink.**
