Inspector Observations: FOUND THE SALAD DRESSING AND THE CHEESE AT 52F IN THE SERVICE REFRIGERATOR AT FRONT OF THE FOOD SERVICE AREA. [CA] KEEP COLD POTENTIALLY HAZARDOUS FOOD AT 41F OR BELOW. NOTE: THE FOOD HAD BEEN STORED IN THIS UNIT FOR A COUPLE OF HRS, PER OPERATOR.SA: IT WAS RELOCATED TO A WORKING REFRIGERATOR.
