K08 - 3 Points - Improperly using time as a public health control procedures & records; 114000

Inspector Observations: Facility is utilizing time as a public health control (TPHC) for boba maintained inside the cooker. Manager stated that boba is prepared in the morning, one hour after opening and is discarded after four hours. A new batch is prepared during the second shift.

Written procedures were unavailable for review.
