Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Observed the hand sink to have items in and on it. A cell phone plastic bags and aprons were on the sink. [CA] The sink must be kept clear and readily available for use. [COS] The employee removed all items from on and inside the sink.

K29 - 2 Points - Toxic substances improperly identified, stored, used; 114254, 114254.1, 114254.2

Inspector Observations: Observed cleaning containers and spray bottles with cleaning products not labeled. [CA] Label all of the spray bottles and containers with the contents inside.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Observed the inside upper panel of the ice machine to have mildew-like accumulation. [CA] Clean and sanitize the panel.

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Inspector Observations: Several shelves have personal items and restaurant items. [CA] Clean and organize shelves. Also, separate personal items from restaurant items.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: The floors have accumulated debris and accumulation of items under the shelves. [CA] Thoroughly clean the floors.
