Observed live cockroaches on the wall behind cooking equipment and on the floor near the kitchen entry. Dead cockroaches were observed on the floor under sinks and on the drainboard of the dishwasher. [corrective action] Eliminate cockroaches from this facility.

This facility is currently operating without a valid Environmental Health Permit from the County of Santa Clara. CLOSURE / PERMIT SUSPENSION NOTICE
