Comments and Observations

Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Observed lack of paper towels and soap in dispenser by handsink in employee restroom and warewashing area. [CA] Provide soap & paper towels in dispenser by handsinks. [COS] PIC refilled soap & paper towel dispensers.

Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

Inspector Observations: PIC unable to provide valid food handler cards. [CA] Ensure all food employees have a valid food handler card and keep certificates on file in facility for review by specialist.

K21 - 3 Points - Hot and cold water not available; 113953(c), 114099.2(b), 114163(a), 114189, 114192, 114192.1, 11419

Inspector Observations: Hot water not working in back handsink. [CA] Provide hot water at a minimum temp of 100F in handsinks.

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

Inspector Observations: Water draining slowly in handsink in employee restroom. [CA] Repair to ensure water adequately drains in handsink in employee restroom.

K42 - 2 Points - Garbage and refuse improperly disposed; 114244, 114245, 114245.1, 114245.2, 114245.3, 114245.4, 114245.5, 114245.6, 114245.7, 114245.8

Inspector Observations: Observed lack of waste receptacle near back handsink. [CA] A receptacle shall be provided in each area of the food facility where waste is generated or commonly discarded.
