### Major Violations

**Inspector Observations: At the 3 composition sink drain board, wet stainless steel containers observed stacked.**

**[CA] Ensure all utensils are properly air dried at all times.**

K41 - 2 Points - Plumbing unapproved, not installed, not in good repair; improper backflow devices; 114171, 114189.1, 114190, 114192, 114193, 114193.1, 114199, 114201, 114269

**Inspector Observations: Low water pressure observed at the 3 composition sink.**

**[CA] Repair plumbing fixture and maintain in clean and good repair.**
