Comments and Observations

Major Violations

No major violations were observed during this inspection.

Inspector Observations: Missing test strip to test sanitizer concentration.

[CA] Testing equipment and materials shall be provided to adequately measure the applicable sanitization method used during manual or mechanical warewashing.

Inspector Observations: Heavy burnt cutting board at food prep table. Per PIC, cutting board is used to torched eel surface.

[CA] Surfaces of equipment shall be smooth, easily cleanable, nonabsorbent, durable, and maintained in good repair.

Per PIC, shrimp tempura is prepared and fried on the stove at Bombay Curry Pizza.
