Comments and Observations

Major Violations

K06 - 8 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Hand wash sink behind the cashier lacked hand soap.

Hand wash sink inside the kitchen observed obstructed with large metal bowl and prepackaged bag of coconut jelly inside the wash basin.

Hand wash sink inside the storage room area completely obstructed with equipment and lacked paper towels.

[CA] Handwashing facilities shall be equipped with handwashing cleanser and single-use sanitary towels in dispensers. Handwashing facility shall be clean, unobstructed, and accessible at all times. Ensure warm water, hand soap, and paper towels are readily available and easily accessible at all times. A handwashing facility shall not be used for purposes other than handwashing.

[COS] Hand soap, paper towels, and obstructions were removed.

Minor Violations

No minor violations were observed during this inspection.

Needs Improvement - Adequate handwash facilities: supplied or accessible.
