Inspector Observations: Observed the restroom paper towel dispenser was empty.

[CA] Keep the paper towel dispenser stocked at all times.

[COS] The paper towel dispenser was refilled.

If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **12/11/2024**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
