One live cockroach found on door next to computer and one live cockroach found on white cable box for computer table. Several dead cockroaches found: 1) one on floor between prep cooler and prep table, 2) three on back side of prep cooler, 3) two on floor between lockers and computer table, 4) one next to fire extinguisher, 5) five on floor underneath computer table. [CA] The premises of each food facility shall be kept free of vermin. A food facility shall not operate when there is a vermin infestation that has resulted in the contamination of food contact surfaces, food packaging, utensils, food equipment, or adulteration of food(s). Facility shall no longer have evidence of a vermin infestation; all contaminated surfaces have been cleaned and sanitized; and contributing factors such as cleaning, repairs, and the elimination of harborages have been resolved.
