THE FACILITY WAS CLOSED DUE TO HAVING NUMEROUS COCKROACHES IN THE KITCHEN.

FINDINGS: THE COCKROACHES HAVE BEEN REMOVED, A PEST CONTROL COMPANY HAS BEEN CALLED TO DO TREATMENT: POLARIS, THEY CAME TWICE FOR TREATMENT ON 12/5 AND 12/6/23. THE MAJORITY OF THE HOLES AND CREVICES HAVE BEEN SEALED. CONTINUE TO SEAL THE REST OF THE CREVICES/GAPS.

THE PERSON IN CHARGE STATES THAT THEY HAVE A CONTRACT WITH THE PEST CONTROL COMPANY TO COME EVERY MONTH.
