Cold holding salad unit ambient air measured 37F. Temperature control on side of unit measured 24F. Food items inside measured 47F. Per PIC, they had refilled the units one hour prior. Ensure that units holding food touch the bottom of the cold holding unit to ensure food is kept within temperature range.
