Follow-up inspection for closure due to cockroach activity.

The following violation was not corrected:

K23M - COCKROACH ACTIVITY

- *By the kitchen area, at the handwash station, observed a single live cockroach in the crevice of the wall corner. Observed wall corner crevices have not been sealed to prevent harborage.*
- *Underneath the steam table, observed two live cockroaches on the shelving and on the plug of a power cable. Observed cockroach droppings around the power plugs/cables.*
- *At the 3 compartment sink, observed large crevice on the left side of the 3 compartment sink has not been fully sealed.*
- *Observed shelf above 3 compartment sink has old caulking that does not fully seal edge. Remove old caulking and add need caulking to properly seal shelving edge.*
- *At the stainless steel cove base around the walk-in refrigerators and along the walls in the area, observed large crevice underneath cove base.*
- *Continue to clean and sanitize all areas with activity and seal all cracks and crevices to prevent continued harborage. Facility must be free of cockroach activity to re-open.*
- *Contact district inspector at 408-918-1955 to schedule follow-up inspection.*

CLOSURE / PERMIT SUSPENSION NOTICE

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **8/31/2021**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.

This notice is to inform you that as of this date the Environmental Health Permit for the above mentioned food facility is hereby suspended and all operations therewith are ordered to cease. This action is taken in accordance with Section 114409 of the California Health and Safety Code which states 'If any imminent health hazard is found, unless the hazard is immediately corrected, an enforcement officer may temporarily suspend the permit and order the food facility or cottage food operation immediately closed.'

You have the right to make a written request for a hearing within 15 days after receipt of this notice to show just cause why the permit suspension is not warranted. Failure to request such a hearing within the 15-day period shall be deemed a waiver of the right to a hearing.
