Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K08 - 3 Points - Improperly using time as a public health control procedures & records; 114000

Inspector Observations: *Per PIC, cooked pizzas at the service line are held on time as a public health control (TPHC). At the time of inspection, observed lack of time markings. No written procedures are available for review. [CA] When time only, rather than time and temperature is used as a public health control, PHFs shall be time marked to indicate when item is removed from temperature control, discarded if not consumed or served within 4 hours, and written procedures shall be readily available for review. [COS] PIC wrote time markings for the pizza and completed TPHC form during inspection.*

K40 - 2 Points - Wiping cloths: improperly used and stored; 114135, 114185.1 114185.3(d,e)

Inspector Observations: *Observed soiled wiping cloths stored on food preparation areas. [CA] Wiping cloths shall be stored in sanitizing solution of an approved concentration when not in use.*
