Major Violations

No major violations were observed during this inspection.

Minor Violations

K08 - 3 Points - Improperly using time as a public health control procedures & records; 114000

Inspector Observations:

Discard time was not written down for the meat cakes at the service area. Per PIC, the meat cake was cooked at 10:30 AM.

[Corrective Action] Write the discard time for perishable foods when left at room temperature.

[Corrected on Site] PIC wrote a discard time of 2:30 PM for the meat cakes.

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Inspector Observations:

The screen for the back door is damaged.

[Corrective Action] Repair the screen. Ensure there are not large openings when leaving the back door open.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations:

Heavy flour accumulation on the floor by the dough mixer and dough press.

[Corrective Action] Maintain floors clean.


