Overall Comments:

This is a follow up inspection to the complaint investigation and limited inspection conducted on 11/24/2023.

No evidence of rodents observed. Per PIC, pest control services were received during closure and will continue.

Wastelines have been replaced in the back preparation area. There are wood panels covering the holes in the ground in the walk in fridge and the warewashing area. Per PIC, only prepackaged foods are kept in the walk in fridge. Facility has a second third compartment sink in the front bar area that is large enough to accommodate pans/dishes needed to operate. The back part of the facility will not be used until a second charged follow up inspection occurs on 12/6/2023 when all cement and tile work are complete. All preparation, cooking, open food storage must be done in the front part of the preparation areas (in front of swinging doors).

Second follow up inspection on 12/6/2023 will be charged \$290/hour minimum one hour to confirm all repairs have been made and facility is able to operate in the back preparation area.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than <u>12/11/2023</u>. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
