Observed rodent droppings on counter next to cold hold inserts, on food cart next to stove, on top of counters, on top of food containers, on floor around mixer, on floor in dry storage area, on shelves in bar area and on floor in bar area. Per PIC, they have pest control. [CA] The premises of each food facility shall be kept free of vermin. A food facility shall not operate when there is a vermin infestation that has resulted in the contamination of food contact surfaces, food packaging, utensils, food equipment, or adulteration of food(s). The food facility shall cease operation of the food facility immediately. The food facility shall remain closed until: there is no longer evidence of a vermin infestation; all contaminated surfaces have been cleaned and sanitized; and contributing factors such as cleaning, repairs, and the elimination of harborages have been resolved. Ensure that all evidence of vermin have been removed. If evidence of vermin is observed facility may be subject to further closure and enforcement action.

CLOSURE / PERMIT SUSPENSION NOTICE

Unless otherwise noted by the inspector, all violations are to be corrected no later than 2/16/2021. Any major change in menu or any change in ownership must have prior approval by this Department. This notice is to inform you that as of this date the Environmental Health Permit for the above mentioned food facility is hereby suspended and all operations therewith are ordered to cease.
