Major Violations

No major violations were observed during this inspection.

Inspector Observations: FOUND A BOX INSIDE THE HAND WASH SINK AND THE PAPER TOWELS OUTSIDE THE WALL DISPENSER AT THE HAND WASH SINK IN THE FOOD PREPARATION AREA. [CA] PROVIDE PAPER TOWELS IN THE WALL DISPENSER AND KEEP THE HAND WASH SINK ACCESSIBLE AT ALL TIMES. COS

K14 - 3 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

Inspector Observations: FOUND THE CHLORINE SANITIZER AT THE 2 COMPARTMENT SINK AT 200 PPM. [CA] PROVIDE 100 PPM.

K33 - 2 Points - Nonfood contact surfaces not clean; 114115(c)

Inspector Observations: FOUND CALCIUM BUILD UP ON THE OUTSIDE OF THE ICE MACHINE. [CA] REMOVE THE BUILD UP.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: FOUND A COUPLE OF SMALL HOLES ON THE WALL BY THE 2 COMPARTMENT SINK. [CA] SEAL HOLES.
