Overall Comments:

This is the first follow up inspection after the facility was closed for an active rodent infestation. A pest control report confirming no rodent activity and a completed and signed checklist for reopening was provided prior to this inspection.

Observations:

K23: No evidence of rodents observed.

K41: The leak at the handwash sink waste pipe has not been repaired.

K45: Facility has cleaned and organized the storage areas. The hole behind the upright cooler has been sealed. Gaps in the room behind the bar have been sealed.

Note: There is a basement accessible from one of the stages on casters. Basement holds unopened liquor bottles. Ensure to limit use of the basement for prepackaged non-potentially hazardous foods in their original unopened containers only.

Facility is okay to reopen.

FACILITY RE-OPENED / PERMIT REINSTATED

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than **9/18/2026**. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
