*- Observed mushroom pizza, manresa pizza, and bbq chicken pizza was not placed on timers. Per operator, mushroom pizza was prepared 30 minutes prior, manresa pizza was prepared an hour prior, and bbq chicken pizza was prepared an hour prior. All other pizzas was properly maintained using timers.*
