Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

Inspector Observations: Observed paper towel dispenser at the only handwash station is empty. No active food preparation is conducted at this facility. [CA] Handwash station shall be fully stocked with soap and single use towels and accessible at all times.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: Observed pressurized cylinder underneath the cabinet is free standing and not secured. [CA] Pressurized cylinder tanks shall be securely stored and fastened to a rigid structure.

Overall Comments:

Per permit condition and SOPs, facility does not conduct food preparation on-site. All food is delivered pre-packaged and stored in heating cabinets until lunch service. Verified that facility utilizes TPHC for all food items, and keeps time and temperature receiving logs.

This facility includes the pantry and break room areas on this floor.

This report was written and signed at the end of site inspections.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
