Note: Stopped by the facility to discuss with the store manager the status of the pest control intervention. During the time of my routine inspection conducted on 08/15/23, many house flies were observed in the deli and bakery area. The store manager was then told to have a pest control intervention and send me a report. However, I did not receive any report from her and I was not able to hold her on a phone line.

During my visit, i learned that the store manager is out of the facility, and many house flies were observed in both the deli and bakery area. I also noted that no pest control intervention was conducted. I told the temporary store manager to have a pest control company conduct intervention in both the Deli and Bakery this week and email me the report.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made. Unless otherwise noted by the inspector, all violations are to be corrected no later than <u>9/5/2023</u>. Any major change in menu or any change in ownership must have prior approval by this Department. This may require structural and/or equipment changes or remodeling to accommodate new operations.
