Major Violations

K14 - 8 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

Inspector Observations: no chlorine residue in dishwashing machine rinse water. advised operators not to use the unit

[CA]maintain dishwashing machine in good repair

Inspector Observations: chicken, tofu, grilled eel in single door prep table cooler in front of charbroil grill at 49F. all perishable items moved to other coolers.

[CA]maintain perishable food under 41F (or 45F for dairy products)

K39 - 2 Points - Thermometers missing or inaccurate; 114157, 114159

Inspector Observations: no probe thermometer

[CA]obtain an accurate probe thermometer

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Inspector Observations: back delivery door with 1/4" gap when closed
