### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

**Inspector Observations: No food handler or food safety certificate available. [CA] At least one employee must have a food safety certificate and all others a food handler card.**

K11 - 3 Points - Improper reheating procedures for hot holding; 114014, 114016

**Inspector Observations: Observed the meat balls on the warmer at 86 degrees F. [CA] The meat balls that were opened yesterday must be reheated to 165 degrees F before putting on the steam table. [COS] The employee threw them away stating that she got busy and was going to reheat in the microwave but will just throw them away.**
