Upon follow-up inspection, observed no signs of LIVE rodent. Pest control came out on 5/23/23 and will be coming back twice a month. Measured cold potentially hazardous foods (PHFs) at or below 41F, hand wash station stocked with soap and papers and plumbing repaired at warewash sink.

Facility is hereby reopen and okay to operate.
