Owner requested follow up inspection.

This is a second charged follow up inspection to the limited inspection conducted on 6/24/2021 and the first follow up inspection conducted on 5/25/2021.

Movable food equipment inside facility was placed outside the facility. Per PIC, it will be cleaned and sanitized prior to being placed back into facility.

Per PIC, pest control services were obtained during closure, pest control report reviewed by inspector. Per PIC, two mice were caught the night prior to the inspection. Glue traps observed throughout kitchen.

PIC is still working to obtain previous pest control reports and will email to district inspector.

Identified several more holes in the ceiling of facility where pipes were coming through that could be entrance points for rodents, holes must be eliminated.

Facility ok to operate.

When required to determine compliance, a single reinspection will be conducted without additional charge. If subsequent reinspections are required, an hourly fee (minimum one hour) at the current rate approved by the Board of Supervisors will be assessed for each and every reinspection until the necessary changes or corrections are made.
