### Major Violations

No major violations were observed during this inspection.

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

**Inspector Observations: sushi rolls and pork slices in 1 door prep table cooler in front of fryer at 44F**  
**[CA]maintain perishable food under 41F**

K14 - 3 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

**Inspector Observations: dishwashing machine with no chlorine residue after 3 sanitizer priming cycles. advised operators not to use the unit until serviced**  
**[CA]maintain dishwashing machine in good repair**
