**Inspector Observations: Found a few flies near sinks and produce back area. [CA] Each food facility shall be free of pest such as flies. Continue to provide approved pest control services.**

### Overall Comments:

**Note: Observed several green crates used to elevate food items off the floor throughout food facility. Discontinue using green crates, use approved shelving.**
