Major Violations

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Flooring next to the mixer in the back of the facility is damaged at the time of inspection.

Per PIC, they have a contractor that will be working on the flooring soon.

[CA] The floor surfaces shall be smooth, of durable construction, and of nonabsorbent material that is easily cleanable.
