Major Violations

No major violations were observed during this inspection.

Inspector Observations: Observed towels in use to cover several food containers in prep area and in walk-in cooler.

[CA] Discontinue the use of cloth towels in direct with food, used approved, single use materials.

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Inspector Observations: Observed several boxes, non functional equipment on top of walk-in cooler.

[CA] The premises of a food facility shall be free of litter and items that are unnecessary to the operation or maintenance of the facility, such as equipment that is nonfunctional or no longer used.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Observed dusty ceilings in walk-in cooler.

[CA] Ceilings of all rooms where non prepackaged food is handled shall be kept clean, smooth, of durable construction, and of nonabsorbent material that is easily cleanable.
