Major Violations

No major violations were observed during this inspection.

Minor Violations

K05 - 3 Points - Hands not clean/improperly washed/gloves not used properly; 113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f)

K30 - 2 Points - Food storage containers are not identified; 114047, 114049, 114051, 114053, 114055, 114067(h), 114069 (b)

Inspector Observations: Observed an unlabeled container of powder. [CA] Label each food container with the contents.

Observed the bulk food rice bin to be deteriorated. [CA] Replace the deteriorated rice bin.

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

Inspector Observations: The dish washing machine tested at 0ppm chlorine. [CA] The dish machine must have 50ppm chlorine. [COS] The employees changed out the chlorine container to a new one and then the machine tested at 50ppm.

K35 - 2 Points - Equipment, utensils - Unapproved, unclean, not in good repair, inadequate capacity; 114130, 114130.1, 114130.2, 114130.3, 114130.4, 114130.5, 114132, 114133, 114137, 114139, 114153, 114155, 114163, 114165, 114167, 114169, 114175, 114177, 114180, 114182

Inspector Observations: Observed the ice bin/soda dispenser to have black accumulation on the outside of it. [CA] Thoroughly clean the equipment.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: Observed the white clean garbage bag used to cover food in the walk in refrigerator. [CA] Discontinue use of the plastic bag for covering food. Use only food grade items such as approved plastic wrap. Observed the cutting boards to be deteriorated. [CA] Replace them with new approved cutting boards.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations: Observed the floor to have accumulated debris behind and under some equipment as shown. Observed accumulation in the floor sinks. [CA] Thoroughly clean the floors and floor sinks.
