## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

**Inspector Observations: Employees preparing food do not have a food handler of food safety certificate. [CA] Each food handler must have a food safety certificate.**

K05 - 3 Points - Hands not clean/improperly washed/gloves not used properly; 113952, 113953.3, 113953.4, 113961, 113968, 113973 (b-f)

**Inspector Observations: Observed employee was hands in the mop sink without hand soap. [CA] Wash hands correctly with soap at the hand sink.**

K06 - 3 Points - Inadequate handwash facilities: supplied or accessible; 113953, 113953.1, 113953.2, 114067(f)

**Inspector Observations: There is only one hand sink in the kitchen and it is blocked by a large garbage can. [CA] Discontinue blocking the hand sink. It is to be readily accessible.**

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

**Inspector Observations: Sanitizer at the dish sink is at 100ppm quat. [CA] It must be kept at 200ppm quat.**
