Major Violations

No major violations were observed during this inspection.

Inspector Observations: FOUND THE SHELVES IN THE WALK IN COOLER WITH FOOD DEBRIS. [CA] CLEAN THE SHELVES MORE OFTEN.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations: FOUND A PLASTIC CUP BEING USED AS A SCOOP FOR THE CHEESE IN THE PIZZA REFRIGERATOR. [CA] PROVIDE A FOOD GRADE WASHABLE SCOOP AND KEEP THE HANDLE OUTSIDE THE FOOD.

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

Inspector Observations: FOUND A JACKET STORED ON TOP OF THE PIZZA BOXES IN THE BACK. [CA] KEEP PERSONAL ITEMS SEPARATE AND AWAY FROM FOOD OR FOOD RELATED ITEMS.
