## Comments and Observations

### Major Violations

K08 - 8 Points - Improperly using time as a public health control procedures & records; 114000

**Inspector Observations: Cooked items packed and left on a table in the dining area. Owner stated that he was using time as public health control (TPHC). However, he could not produce a written policy and no time markers were in place. Items were placed on the tables at 12 pm, according to the owner [CA] Must have a written policy and place time markers for a maximum of 4 hours after which items are discarded. Owner wrote the policy during the inspection and discarded the items by the end of inspection.**

### Minor Violations

K32 - 2 Points - Food improperly labeled & not honestly presented: 114087, 114089, 114089.1(a, b), 114090, 114093.1

**Inspector Observations: REPEAT VIOLATION**

**Foods packaged on site lack proper labeling [CA] Owner showed me the labels but had not put them on the packages.**
