### Major Violations

K01 - 3 Points - Inadequate demonstration of knowledge; food manager certification

**Inspector Observations: There is not an employee with a food safety certificate. [CA] At least one employee must have a food safety certificate.**

K34 - 2 Points - Warewashing facilities: not installed or maintained; no test strips; 114067(f,g), 114099, 114099.3, 114099.5, 114101(a), 114101.1, 114101.2, 114103, 114107, 114125

**Inspector Observations: The test strips for the dish machine are not available. [CA] The chlorine test strips are needed for the dish machine.**

### Overall Comments:

**The water does take a few minutes to get hot. Adjust it so that it gets hot while hand washing.**
