## Comments and Observations

### Major Violations

No major violations were observed during this inspection.

### Minor Violations

K07 - 3 Points - Improper hot and cold holding temperatures; 11387.1, 113996, 113998, 114037, 114343(a)

**Inspector Observations:** *Observed the hot food case to not hold the back items 135 and above. They are approximately 131 degrees F and just made this morning. [CA] The hot food case must hold all food inside of it at 135 degrees F and above. [COS] The temperature was turned up and it all reached 135 degrees F and above.*

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations:** *Observed the floor to have broken areas that are accumulating debris. [CA] Clean and repair the broken areas of the floor.*
