### Major Violations

**Inspector Observations: There was no paper towel supply in the restroom.**

**[CA] Refill the paper towel dispenser. Until the wall-mounted paper towel dispenser is refilled, please provide a roll-type paper towel or napkins. The PIC provided a roll-type paper towel (COS).**

### Minor Violations

**Inspector Observations: Heavy slime buildup was observed inside the ice machine's internal part.**

**[CA] Clean the internal part of the ice machine immediately.**

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

**Inspector Observations: The ice scoop for the ice machine was stored on unclean surface.**

**[CA] All reusable utensils including the ice scoop must be stored on clean surface/container in between use.**

K44 - 2 Points - Premises not clean, not in good repair; No personal/chemical storage; inadequate vermin-proofing; 114067(j), 114123, 114143 (a,b), 114256, 114256.1, 114256.2, 114256.4, 114257, 114257.1, 114259, 114259.2, 114259.3, 114279, 114281, 114282

**Inspector Observations: There is no wet mop hanger by the janitorial sinks.**

**[CA] Install a wet mop hanger by the janitorial sink. All wet mops must be hanged on the wet mop hanger.**

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

**Inspector Observations: The ceiling back in the storage area is falling off.**

**[CA] Replace the damaged/broken or missing ceiling tiles immediately.**
