The follow up inspection conducted due to major temperature and dish washing violations.

Upon inspection:

Upright dishwasher measured to have 167F rinse cycle. Monitor final rinse temperature of dishwasher regularly to ensure dishes are properly sanitized.

Upright warmer by mop room measured to have:

-Enchiladas in green sauce at 137F

-Enchiladas in red sauce at 136F

All major violations have been corrected. Continue to work on minor violations from previous routine inspection report.
