Comments and Observations

Major Violations

No major violations were observed during this inspection.

Minor Violations

K14 - 3 Points - Food contact surfaces unclean and unsanitized; 113984(e), 114097, 114099.1, 114099.4, 114099.6, 114101, 114105, 114109, 114111, 114113, 114115(a,b,d), 114117, 14125(b), 114141

Inspector Observations:

Chlorine sanitizer in the dishwasher was measured at 25 ppm.

[Corrective Action] Maintain chlorine sanitizer at 50 ppm.

K36 - 2 Points - Equipment, utensils, linens: Improper storage and use; 114074, 114081, 114119, 114121, 114161, 114178, 114179, 114083, 114185, 114185.2, 114185.3, 114185.4, 114185.5

Inspector Observations:

1. Knives observed stored in the crevice between the prep cooler and work table.

[Corrective Action] Discontinue storing knives in the crevice.

2. Pressurized cylinders by the ice machine observed not secured to a rigid structure.

[Corrective Action] Secure pressurized cylinders to a rigid structure.

K45 - 2 Points - Floor, walls, ceilings: not built, not maintained, not clean; 114143(d), 114266, 114268, 114268.1, 114271, 114272

Inspector Observations:

Broken cove base tile observed in the kitchen by the fire extinguisher.

[Corrective Action] Maintain floors in good condition.
