Three live adult cockroaches were observed in the gasket of the 2 door prep cooler in the service area. Dead cockroaches observed on the floor behind the 2 door prep cooler and the ice machine.

[Corrective Action] A food facility shall not operate in the presence of an active infestation.

[Suitable Alternative] The three live adult cockroaches were all eliminated by the Person in Charge.
